

EARLY CHILD CARE & DEVELOPMENT ONLINE BACHELOR OF SCIENCE PROGRAM



This 100% online 120-hour degree program prepares students to work in early childhood settings with young children, especially those whose family members are highly mobile. Early Child Care and Development specialists create environments that are healthy, respectful, supportive and challenging for each child. Specialists design, implement, and evaluate experiences that promote positive development for young children. Graduates are qualified to work in a variety of programs that offer early care and education in the community and on military installations. **Early Child Care and Development is a 100% online undergraduate program** delivered collaboratively by seven universities through the Great Plains Interactive Distance Education Alliance (Great Plains IDEA). Admission to the program is a two-step process: 1) admission to Oklahoma State University, and 2) admission to the program.

PROGRAM HIGHLIGHTS

- Curriculum developed by early child care experts at seven universities.
- Three practicum experiences provide hands-on opportunities and exposure to real-life scenarios.
- Focus on ethics and guidelines related to early childhood practice.
- Classroom management and program administration experience.
- This degree program does not lead to teaching licensure.

INFORMATION FOR ADMISSION TO THE EARLY CHILD CARE AND DEVELOPMENT PROGRAM:

- Students must have completed 30 credit hours that can be used toward graduation requirements and a minimum 2.5 overall GPA (These hours must include a "Lifespan Human Development" Course.)
- Transfer students may transfer six credit hours of core courses (approved courses are child development course; health, safety and nutrition course) not including professional development courses.
- 2.5 overall GPA or higher must be maintained throughout the entirety of the program.
- No course can be taken more than twice due to failure or incomplete status.
- Waiver of Practicum 1 for students with qualifying experience depends upon specific past work experiences and must be approved by a committee of program faculty.
